

Daily Payables Fees

In case contractual fee/transaction cost of a term loan reaches its maturity date, it will be considered as a daily payable asset.

Usually daily payables are equalised against a settlement account through a client payment.

In case the payment related to fees/transaction costs does not cover the entire amount of the daily payable interest, the remaining amount is shown in the measure Daily Payable Fees.
