

Interest Smoothing IFRS

The measure "Interest Smoothing IFRS" is a valuation element which is in general calculated similar to the general measure "[Interest Smoothing](#)".

Hence it can differ between GAAPs because it considers the measure [effective interest rate](#) as input for which GAAP-specific settings can be defined.
